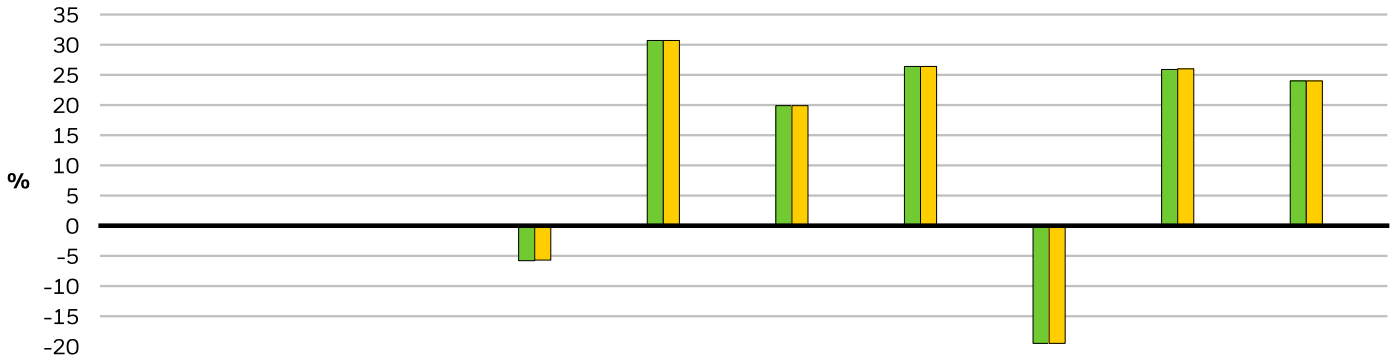

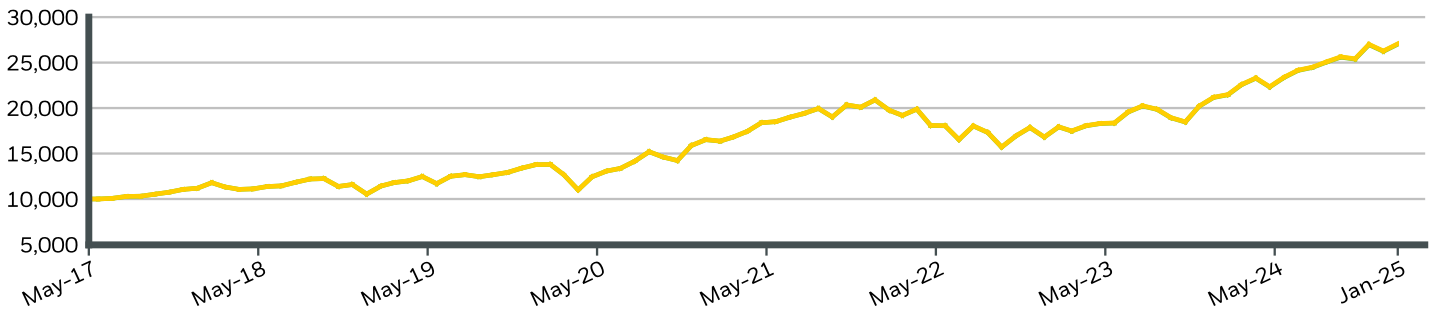

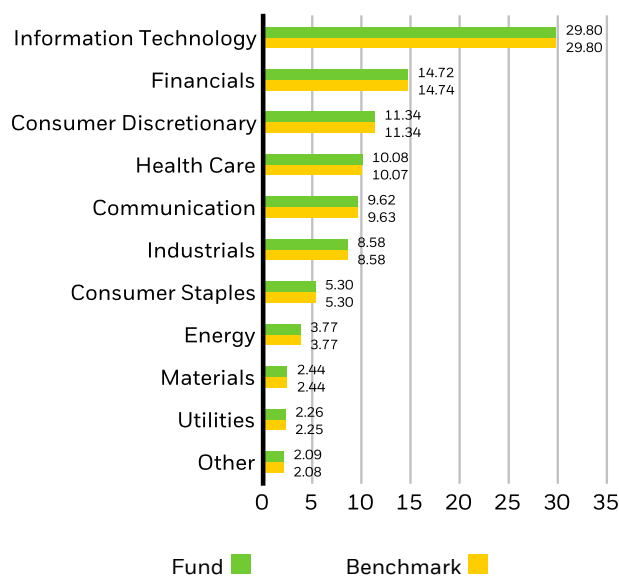

GLOSSARY
